TO OBTAIN MONEY OR PROPERTY BY GIFT, BEQUEST OR DEVISE AND TO INVEST AND REINVEST THE SAME, AND TO APPLY THE INCOME AND PRINCIPAL THEREOF, AS THE BOARD OF DIRECTORS OR THE APPROPRIATE OFFICERS MAY FROM TIME TO TIME DETERMINE, EXCLUSIVELY FOR CHARITABLE PURPOSES, INCLUDING, BY WAY OF EXAMPLE AND NOT LIMITATION, PROVIDING SEPARATELY AND TOGETHER WITH OTHER GROUPS, AID AND ASSISTANCE TO COMMUNITIES IN AFRICA AND OTHER COMMUNITIES SEEKING AID AND ASSISTANCE, WITH EMPHASIS UPON PROVIDING SITUATIONS IN WHICH SCHOOL-AGE CHILDREN PROVIDE OR PARTICIPATE IN A SUBSTANTIAL PORTION OF THE AID AND ASSISTANCE AND LEARN ABOUT THE CULTURE OF THE COMMUNITIES TO WHICH SUCH AID AND ASSISTANCE IS PROVIDED AND TO ENGAGE IN ANY AND ALL LAWFUL ACTIVITY INCIDENT THERETO, EXCEPT AS RESTRICTED HEREIN.
